#### Part A: SEARCH AND RESCUE

#### Rescue( )

**Rescuer** members are the main body of individuals who are operational members. Rescuers train for and respond to emergency and non-emergency rescue incidents. Rescuer members have voting privileges.

Rescuers are trained in all areas of rescue. Activities include responding to emergency and non-emergency incidents, driving trucks, performing search and rescue duties, interacting with emergency agencies, and assisting with non-rescue tasks to help keep the organization functioning smoothly.

BES rescuers are required to attend a percentage of regular trainings on both Mondays and Saturdays each month. Work as a BES rescuer can be time consuming and strenuous, but also can be extremely rewarding.

## Adjunct )

**Adjunct** members are individuals with specialized skills who intend to supplement rescue operations in specific roles and capacities. Adjunct members are not eligible to be elected as Chief or appointed to a Field Officer position. Adjunct members are non-voting members.

Once accepted as an applicant, both the **Rescuer** and **Adjunct** member will be required to take orientation and candidate training. The training usually is in the form of an academy and optionally may be a self-paced informal process. The Candidate Academy is conducted on an as needed basis usually once per year. Applicants are welcome to apply and then attend meetings and trainings in advance of the academy.

#### Part B: ADMINISTRATIVE

### **Associate**

**Associate** members assist with non-rescue related activities like administrative tasks. Associate members are non-operational and do not have voting privilege. This level of involvement allows for participation as a

volunteer without the large time commitment as a rescuers. If applying for Associate member, then the Candidate training is waived.

#### **NEXT STEPS**

If you decide you would like to pursue becoming a part of BES, here's what you need to do:

#### Meet the Minimum Requirements for BES Membership:

- Be at least 18 years of age (17 y/o for the Cadet program with special permission of President)
- Have a clean criminal history and driving record
- Live and/or work in Boulder County
- Be willing to participate in all BES activities, emergency and non-emergency incidents, training, drills and exercises, and assist with activities such as vehicle and equipment maintenance, inventory, community outreach, cleaning, committee work, and other such duties.

#### **Complete the Application Process:**

- 1. Attend a minimum of 15 scheduled public events.
  - o We usually meet 3-4 Monday evenings and the 2-3 Saturday mornings per month. A calendar is found on the website.
- 2. Complete this application including initialing and signing all pages as indicated including full signature on last page and return it to the **Recruiter** along with:
  - o 1 copy of your driver's license, and
  - o 1 copy of your Colorado Driver's Record.
- 3. A background investigation will be conducted of your criminal history.

#### What will happen next:

- The membership will review your application and vote 'yes' or 'no' for you to be brought into the squad to the position requested. If 'yes', then you will be informed and guided on what to do next.
- You can expect to begin attending all BES training and meeting activities. However, you should not expect to go on rescue missions until directed to do so.
- If voted in as Candidate member toward becoming a Rescuer or Adjunct member, you will proceed through the Candidate training process.
- If as an Associate, then there are no other steps and you can begin volunteering with the team in an administrative support position right away.
